## 2. Hazards Identification

**Emergency overview** EXTREMELY FLAMMABLE  
CONTENTS UNDER PRESSURE.  
Aerosol. Pressurized container may explode when exposed to heat or flame.  
  
Irritating to skin. Irritating to eyes. Irritating to respiratory system. Prolonged exposure may cause chronic effects.

**Potential health effects**

**Routes of exposure** Inhalation. Skin contact.

**Eyes** Causes eye irritation.

**Skin** Irritating to skin. Prolonged or repeated contact can result in defatting and drying of the skin which may result in skin irritation and dermatitis (rash).

**Inhalation** Intentional misuse by concentrating and inhaling the product can be harmful or fatal. Irritating to respiratory system. Prolonged inhalation may be harmful.

**Ingestion** Exposure by ingestion of an aerosol is unlikely. Ingestion may cause gastrointestinal irritation, nausea, vomiting and diarrhea. May cause delayed lung damage.

**Target organs** Central nervous system. Respiratory system.

**Chronic effects** May cause central nervous system disorder (e.g., narcosis involving a loss of coordination, weakness, fatigue, mental confusion, and blurred vision) and/or damage. May cause delayed lung damage.

**Signs and symptoms** Discomfort in the chest. Narcosis. Defatting of the skin. Irritation.

## 4. First Aid Measures

**First aid procedures**

**Eye contact** Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Get medical attention if irritation develops or persists.

**Skin contact** Remove and isolate contaminated clothing and shoes. Wash off with warm water and soap. Get medical attention if irritation develops or persists.

**Inhalation** Move to fresh air. If breathing is difficult, give oxygen. Call a physician if symptoms develop or persist.

**Ingestion**

Have victim rinse mouth thoroughly with water. Get medical attention immediately. Do not induce vomiting without medical advice. If vomiting occurs naturally, have victim lean forward to reduce risk of aspiration. Do not use mouth-to-mouth method if victim ingested the substance. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device.

## 5. Fire Fighting Measures

**Flammable properties**

Containers may explode when heated. Vapor or gas may spread to distant ignition sources and flash back.

**Extinguishing media****Suitable extinguishing media**

Water fog. Foam. Dry chemical. Carbon dioxide (CO<sub>2</sub>). Halons.

**Unsuitable extinguishing media**

Do not use a solid water stream as it may scatter and spread fire.

**Protection of firefighters****Specific hazards arising from the chemical**

Fire may produce irritating, corrosive and/or toxic gases.

**Protective equipment and precautions for firefighters**

In the event of fire and/or explosion do not breathe fumes. Wear full protective clothing, including helmet, self-contained positive pressure or pressure demand breathing apparatus, protective clothing and face mask. Containers should be cooled with water to prevent vapor pressure build up. For massive fire, use unmanned hose holders or monitor nozzles; if this is impossible, withdraw from area and let fire burn.

## 6. Accidental Release Measures

**Personal precautions**

Ensure adequate ventilation. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering. Keep unnecessary personnel away.

**Methods for containment**

Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if you can do so without risk. Move the cylinder to a safe and open area if the leak is irreparable.

**Methods for cleaning up**

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean contaminated surface thoroughly.

## 7. Handling and Storage

**Handling**

Pressurized container: Do not pierce or burn, even after use. Do not handle or store near an open flame, heat or other sources of ignition. Use only in area provided with appropriate exhaust ventilation. Do not use if spray button is missing or defective. Do not get this material in contact with eyes. Do not get this material in contact with skin. Do not breathe gas/fumes/vapor/spray. Wear personal protective equipment. Avoid prolonged exposure.

**Storage**

Level 3 Aerosol.

Contents under pressure. Do not puncture, incinerate or crush. The pressure in sealed containers can increase under the influence of heat. Do not handle or store near an open flame, heat or other sources of ignition. Avoid exposure to long periods of sunlight. Store in cool place. Keep in an area equipped with sprinklers. Keep out of the reach of children. Use care in handling/storage.
